4. Motions submitted for Members' Business are shown below—

Bob Doris: S6M-08071: Rare Disease Day 2023 - That the Parliament notes that Rare Disease Day 2023 takes place on 28 February and that the theme for the global day is Share Your Colours, which is a call to patients, governments and all stakeholders in positions of power to do all that they can to remove the stigma around patients with rare diseases, and to work collaboratively to raise awareness of the challenges that such patients face; welcomes that this year will see the return of an in-person rare disease parliamentary event in the Scottish Parliament on 15

March; recognises the significance of Rare Disease Day and annual parliamentary reception to people in Scotland with rare diseases; understands that over 320,000 people in Scotland are living with a rare condition; further understands that one in 17 people will be affected by a rare condition at some point in their lives and that the majority of rare conditions have no effective treatment; understands that, on average, it takes over four years to receive an accurate diagnosis of a rare condition, and that there are over 7,000 rare conditions, including rare cancers such as childhood cancers and other well-known conditions such as cystic fibrosis and Huntington's disease; welcomes the publication of the Rare Disease Action Plan for Scotland, which launched on 19 December 2022; notes the view that there is a need for ongoing engagement with people with rare diseases to ensure that the plan is successfully implemented, and further notes the belief that the plan should form the basis of ongoing engagement with people in Scotland with rare diseases in order to deliver for those with rare, genetic and undiagnosed conditions, as well as their families.

Jackie Ballie: S6M-07996: International Long Covid Day - That the Parliament recognises that 15 March 2023 is International Long Covid Day; understands that, in Scotland, it is estimated that 187,000 people have long COVID; further understands that there is currently no simple cure and that long COVID can affect people of any age and background, including children, regardless of the severity of their original COVID-19 symptoms; considers, with regret, that the funding available for treatment, support and clinical research, remains too low; is concerned at reports that there is an increasing postcode lottery for specialist NHS services in Scotland for the diagnosis and treatment of the condition, potentially leading to inequalities in patient outcomes; notes the belief that key workers with occupational long COVID should receive compensation and pension entitlements; further notes the view that more should be done in respect of improving air quality through CO2 monitoring and HEPA filtration in schools and public buildings, and notes the view that more work is needed to understand and treat what it sees as an often debilitating illness.

Pam Gosal: S6M-07992: International Women's Day 2023 - That the Parliament recognises the achievements of women around the world on International Women's Day on 8 March 2023; welcomes the 2023 theme of #EmbraceEquity, which seeks to open up the conversation about why equal opportunities are no longer enough, and that equity is the means through which to achieve equality; believes in a world free of bias, stereotypes and discrimination; notes the calls to raise awareness about discrimination, to celebrate women who forge change in society, and to build equity in all areas of society, including in healthcare, and further notes the belief that it is incumbent on all politicians to work together to pursue true equity for the benefit of women across the whole of society.

S6M-07967: Alexander Stewart: Healthy AGeing in Scotland - That the Parliament acknowledges that the University of Stirling-led Healthy AGeing In Scotland (HAGIS) study is the first of its kind to follow individuals and households across Scotland, including in the Mid Scotland and Fife region, through the passage of time; understands that the study, which was launched on 24 July 2015, is an ongoing, major Scotland-wide study of the health, economic and social

circumstances of people over 50, which will enable future improvements to be made to the health and wellbeing of this age group; believes that there are currently two million people over 50 in Scotland, comprising 38% of the population; understands that the HAGIS study will capture a snapshot of the current circumstances of 1,000 people over 50; further understands that, following its findings in Autumn 2016, the aim was to expand the study to 8,000 people in 2018, charting changes in their health and social circumstances over the decades and reporting every two years; notes that the multi-partner HAGIS project team includes the Universities of Strathclyde and Edinburgh; believes that, while people in Scotland are now living longer and the size of the older population is increasing, the country historically possesses a relatively poor health record and significant levels of income inequality; considers that, as a result of its extensive research since inception, the HAGIS study is proving to be what it sees as an extremely valuable and important new member of the growing worldwide network of longitudinal ageing studies, uncovering the unique health and social circumstances currently experienced by Scotland's ageing population; acknowledges the United Nations Decade of Healthy Ageing (2021–2030), which is a global collaboration, aligned with the last ten years of the UN Sustainable Development Goals, to improve the lives of older people, their families, and the communities in which they live; understands that the three domains of healthy ageing are physical ageing, mental/cognitive ageing and social wellbeing ageing; considers that harmonised data from HAGIS will permit quantitative comparisons of the ageing processes in Scotland with findings from the other members of the Health and Retirement Study family, which now covers more than 50% of the world's over-50 population, and commends the University of Stirling and its multi-partner university project team for embarking on what it considers as a significant and invaluable study into the improvement of health and wellbeing in the lives of Scotland's growing ageing population.

S6M-07928: Jackson Carlaw: East Renfrewshire Good Causes - That the Parliament acknowledges what it sees as the incredible and transformative work of charities in the Eastwood constituency and across Scotland; welcomes the ongoing contribution of East Renfrewshire Good Causes in providing what it considers outstanding support to vulnerable members of local communities; understands that, in the period since the charity was established and first started to offer much-needed support in August 2007 and up to September 2022, East Renfrewshire Good Causes has provided £1.6 million in goods and services and helped 5,400 individuals; acknowledges that examples of support that the charity has funded, either in full or in part, include wet floor shower adaptations for disabled pensioners, help with travel costs for cancer patients on low incomes to attend hospital for treatment, and play spaces and equipment for young people with additional support needs; considers that the set-up of the charity means that it can respond very quickly to emerging circumstances and is able to undertake essential tasks in a short timescale, such as assisting with practical home support improvements needed to allow older people to be discharged from hospital to free up beds for incoming patients; recognises that all referrals to the charity are made by frontline professionals, including teachers, housing officials and health and social care staff, from both the public and third sector; understands that the operations of East Renfrewshire Good Causes have

expanded over the years and that the charity is also now active in Glasgow, South Lanarkshire, Renfrewshire and East Ayrshire; congratulates the founder and project coordinator of East Renfrewshire Good Causes, Russell MacMillan, for what it sees as the remarkable and selfless efforts that he has made for more than 15 years in driving the Eastwood-based charity forward and ensuring that vital support has been provided to people in need, and considers that East Renfrewshire Good Causes has demonstrated a strong track record of delivery and established an operating model that has the potential to be replicated in all local authority areas across Scotland.

S6M-07924: Michelle Thomson: Taliban Suppression of Women and Girls in Afghanistan - That the Parliament condemns the actions of the Taliban in Afghanistan, which it believes have further restricted the freedoms and opportunities for Afghan women and girls; understands that the reported ban on women accessing university education in Afghanistan, enforced from December 2022, is in addition to the ban on girls attending secondary school; considers that this lost education will have a detrimental impact on skills and knowledge in Afghanistan, including its causal effect on professions such as education, healthcare and local government, as well as on economic growth; understands that United Nations officials have reportedly condemned these actions as a violation of Afghanistan's obligations under international law; further understands that, in July 2022, the UK Government confirmed its continued pressure on the Taliban to reverse its actions, and reiterated its support to provide emergency education funding through the United Nations' Education Cannot Wait fund and the Global Partnership for Education; believes that the actions of the Taliban continue to suppress women and girls in Afghanistan, and have led to what it sees as the desperate actions many women and children have taken by fleeing Taliban oppression and resettling in other countries, including the UK; considers that this has allowed those people to receive education, achieve their potential, and live a better quality of life; acknowledges the support that it considers the Scottish Government has provided to people resettling in Scotland due to conflict through the Afghan Citizens Resettlement Scheme and the New Scots Connect network, implemented by the Scottish Refugee Council; recognises the contributions of local groups across Scotland, including those in the Falkirk district, which operate to support refugees, and notes the calls for additional cross-government support to assist in both putting pressure on the Taliban to reverse its actions, and further supporting Afghan citizens, including women and children, who have resettled in Scotland to realise their potential.

S6M-07897: Stuart McMillan: Proposed Closure of Amazon Gourock - That the Parliament regrets the decision taken by Amazon to announce the potential closure of its Gourock facility, in the Greenock and Inverclyde constituency; understands that, on 9 January 2023, Amazon unexpectedly announced to its staff that it was launching a consultation on the proposed closure of the site, potentially making around 300 people unemployed; acknowledges reports that Amazon has offered to relocate its Gourock-based staff to other facilities it operates in Scotland; understands that the only similar site in Scotland is located in Dunfermline, which has reportedly led to an acceptance that it is unlikely that the majority of the Gourock-based staff will move to another position within the company; notes with

concern that Amazon is reportedly yet to explain its rationale for closing the site to its staff, local elected representatives, and the Scottish Government; understands that the age of the building at the Faulds Park location may have been a factor in the decision; believes that, if that is the case, concerns about the age of the building had not been raised with any elected representatives who have visited the facility; further believes, regrettably, that Amazon may have already made the decision to close the facility, even before the consultation has finished, in light of reports that, when senior Amazon employees have been asked what will happen in the event that the consultation finds that staff want the facility to stay open, no commitment has been made to respect the outcome of the consultation; considers that, in effect, this would make it a consultation in name only; notes the calls for Amazon to put its staff before its profits, of which it has reportedly made what it considers an astronomical amount in recent years, and further notes the calls for Amazon to commit to the Gourrock facility on a new long-term lease and, if this is not going to happen, to be honest with its staff, and the wider Inverclyde community, as soon as possible, so that the staff can explore opportunities to gain alternative employment and the landlord can find a new tenant for the building.

S6M-07890: Emma Harper: Wear A Hat Day 2023 - That the Parliament recognises what it sees as the importance of Wear A Hat Day, taking place on 31 March 2023, in raising awareness of brain tumours; understands that brain tumours are the biggest killer of children and adults under 40 with cancer in Scotland, reducing life expectancy by 20 years on average; believes that this is the highest life expectancy reduction of any cancer, but that the treatment and understanding of brain tumours are 20 years behind those relating to more common cancers; notes that brain tumours often cause side effects that have a severe impact on a person's quality of life; understands that there are over 130 different types of brain tumour, and that some symptoms of brain tumours can mimic other equally serious conditions, which often renders early diagnosis and treatment more difficult in many cases; further understands that brain tumour charities, such as the Brain Tumour Charity, are working hard to fund pioneering research, raise awareness of the signs and symptoms of brain tumours, and provide support to people affected by brain tumours; commends the success of national campaigns, which it considers have contributed to a reduction in the average diagnosis time for childhood brain tumours, from 9.1 to 6.5 weeks, since 2011; believes that national campaigns are a basis on which to develop further awareness; notes the significant efforts of Dumfries and Galloway Medical Physics Technician, Alan Johnstone, in both raising awareness of brain tumours and funding for research and development into the causes of brain tumours, their treatment and, ultimately, a cure; understands that Alan's late wife, Aneka Johnstone, was diagnosed with a glioblastoma brain tumour and sadly died in 2019, despite being a very fit and active 33-year-old, and further understands that, despite losing Aneka, Alan has raised more than £55,000 for the Brain Tumour Charity by walking the 214-mile Southern Upland Way, videos of which were posted to Alan's TikTok account, which has attracted a huge following.

S6M-07793: Finlay Carson: Welcoming the Contribution of Rural Estates to Scotland's Wellbeing Economy - That the Parliament welcomes the publication of

the report, *The Contribution of Rural Estates to Scotland's Wellbeing Economy*, by Scottish Land and Estates; believes that this report, for which the research was carried out by BiGGAR Economics Ltd and Scottish Land and Estates, is an innovative example of a whole sector measuring its outputs against Scotland's National Performance Framework's National Outcomes rather than just through traditional economic metrics; considers that the report describes and quantifies how rural estates drive local economic development through agriculture, forestry, tourism, sporting, recreation and renewable energy generation, act as stewards of the natural environment, protect and enhance biodiversity, support the transition to net zero, provide homes and create sustainable new communities, provide a gateway to nature, and function as anchors of communities and support community-led projects; further considers that the report also identifies areas in which there is scope for estates to increase their contributions across the National Outcomes, and provides an improvement framework to complement the research; recognises Scotland's rural estates as, it considers, key delivery partners of the Scottish Government across a wide range of policy areas, including improving outcomes for people, jobs, and nature across the country, including in the Galloway and West Dumfries constituency, and commends the sector for what it sees as its commitment to this innovative work.

S6M-07769: Evelyn Tweed: National Lyme Disease Awareness Month -

That the Parliament acknowledges that May 2023 is National Lyme Disease Awareness Month; notes that Lyme disease is a bacterial infection spread to humans by infected ticks, which are tiny spider-like creatures found in woodland and moorland areas that feed on the blood of birds and mammals, including humans; understands that many people with early symptoms of Lyme disease develop a circular rash around the tick bite three to 30 days after being bitten, often described as looking like a bull's eye on a dart board, whilst some people may develop several rashes in different parts of their body, and around one in three people will not develop a rash; further understands that some people with Lyme disease also have flu-like symptoms, including tiredness, muscle and joint pain, headaches, a high temperature, chills and neck stiffness; notes the calls encouraging anyone who has been bitten by a tick and develops a rash or flu-like symptoms to speak to their GP and tell them that they have been bitten by a tick; further notes, however, that diagnosing Lyme disease is often difficult as many of the symptoms are similar to other conditions; acknowledges that NHS Scotland advises that Lyme disease is treatable, however, that without treatment, more serious and longer-term symptoms may develop, including pain and swelling in joints, nerve problems, memory problems, difficulty concentrating and heart problems; understands that there is currently no vaccine available and that the best way to prevent Lyme disease is to adopt simple measures when in the countryside or near wildlife, including tucking trousers into socks and wearing insect repellent, and notes the calls encouraging anybody who is concerned that they have contracted Lyme disease to contact their GP and for everyone to take precautions when in the countryside.

S6M-07752: Gillian Martin: Marie Curie's Great Daffodil Appeal 2023 - That the Parliament welcomes Marie Curie's Great Daffodil Appeal 2023, which runs

throughout March; praises Marie Curie nursing and hospice staff who continue to provide palliative and end of life support, across Scotland in people's homes and in its two hospices in Edinburgh and Glasgow, during challenging times; understands that Marie Curie cared for over 8,660 people during 2021-22; commends the dedication, hard work and contribution of Marie Curie volunteers across Scotland; considers that the COVID-19 pandemic highlighted how important equitable access to palliative and end of life support is for people affected by terminal illness; notes that donations can be given to the appeal, and that daffodil pins are worn in memory of someone who has died; understands that Marie Curie needs to raise £250,000 per week to support its frontline services; commends the vital care and support that Marie Curie provides across Scotland, including in the Aberdeenshire East constituency; praises its information and support services, which are available for everyone affected by terminal illness, including for bereavement support, and its volunteer helper services, which provide vital emotional support, companionship and information to terminally ill people, carers and families; believes that wearing the daffodil pin unites millions of people who believe that dying people should get the care and support that they need; considers that the funds raised will mean a great deal to terminally ill people, and notes the calls encouraging as many people as possible to support the Marie Curie Great Daffodil Appeal in March 2023.

S6M-07711: Christine Grahame: St Andrew's Children's Society -

That the Parliament congratulates St Andrew's Children's Society on marking its centenary in 2022; understands that St Andrew's Children's Society is the oldest adoption and fostering agency still in existence in Scotland; recognises what it sees as the valuable work that the Society does connecting vulnerable children to safe and loving homes, including in the Midlothian South, Tweeddale and Lauderdale constituency; understands that it is the only agency in Scotland to offer the SafeBase parenting programme, which is a therapeutic programme for parents of adopted and fostered children who have attachment difficulties; notes that over £20,000 has been raised during the centenary and that a number of events have been held, including a Family February FUNdraising challenge, a fundraising concert by Cadenza and a parliamentary reception in the Scottish Parliament, and that a special commemorative booklet was also written by Maureen McEvoy MBE; pays credit to all of the staff and volunteers who have supported the Society over the last 100 years, with particular credit to the adopted and foster parents who have provided safe and loving homes to their adopted and foster children, and extends its best wishes to all who are involved in adoption and fostering.

S6M-07686: Pauline McNeill: Supporting Taxi Drivers - That the Parliament recognises the contribution that taxi drivers make to the economy, connectivity and cultural life of Glasgow and the Greater Glasgow region; believes that taxi drivers provide a vital service to people who have mobility problems that make other forms of public transport unsuitable; understands that the service that taxi drivers provide does much to support what it sees as Glasgow's important night-time economy and hospitality industry, as well as provide the transport options which contribute to making Glasgow a UNESCO World City of Music; recognises the longstanding charity work carried out by Glasgow's taxi drivers through events such the Glasgow

Taxi Outing To Troon; considers that recent years have brought unprecedented challenges to taxi drivers, with the COVID-19 pandemic reducing passenger numbers, and significant regulation changes from Glasgow City Council mandating vehicle changes which, it believes, are unaffordable to many within the industry; notes the campaign from some taxi drivers for a fair implementation of new regulations, and congratulates the sector for all it contributes to the city.

S6M-07627: Stephen Kerr: Whistleblowing Awareness Week 2023: That the Parliament is aware that Whistleblowing Awareness Week occurs between 20 and 24 March 2023; considers that whistleblowing is crucial to a free and open society; understands that Whistleblowing Awareness Week is an opportunity to celebrate people who have courageously spoken up about various workplace issues and organisations that have promoted whistleblowing within their organisation, and notes the view that Whistleblowing Awareness Week is an opportunity to acknowledge that existing whistleblowing legislation requires root and branch reform.

S6M-07622: David Torrance: Alex James Colquhoun Elected as Vice President of the European Showman's Union - That the Parliament congratulates Alex James Colquhoun after being elected as the Vice President of the European Showman's Union; understands that Alex James was elected to the position of vice president after what it sees as his tireless efforts in assisting and working to improve the lives of showpeople in Scotland with fundamental issues, most recently through the provision of funding during the COVID-19 pandemic; further understands that Alex James is also the current chairman of the Scottish Section of The Showman's Guild and that he brings a wealth of knowledge to his new role; believes that Alex James has been instrumental in the return, since the pandemic, of Burntisland's Summer Fair and Kirkcaldy's Links Market, which was established in 1304 and is Europe's longest street fair as well as the oldest in Scotland; notes that Alex James is a member of the Cross-Party Group in the Scottish Parliament on the Scottish Showmen's Guild, which highlights what it sees as the importance of Scottish showmen as a contributing group to communities across Scotland; commends Alex James for his dedication to showpeople, and wishes him all the best for the future.

S6M-07555: Sandesh Gulhane: Chronic Kidney Disease in Scotland -

That the Parliament understands that chronic kidney disease affects more people in Scotland than cancer and that there is no cure; further understands that only around two thirds of those affected by kidney disease have received a diagnosis, with many of them diagnosed too late to prevent renal failure, while others are identified by accident when tested for other conditions; believes that there are significant opportunities to address inequalities in the diagnosis and outcomes for people in Scotland, including in the Glasgow region, with chronic kidney disease, based on their backgrounds; marks the launch of the Kidney Research UK report, Changing the future for chronic kidney disease in Scotland, which it understands makes key recommendations to transform the outcomes for people in Scotland with chronic kidney disease, and notes the calls on patients and their advocates, families, clinicians, researchers, NHS leaders and policymakers to work together to devise and deliver a national approach that can transform kidney health in Scotland, prevent more people developing this potentially life-threatening disease, slow its progression,

avoid preventable complications and reduce the number of people needing dialysis or an organ transplant.

S6M-07514: Michael Marra: Final Report of the Independent Oversight and Assurance Group on Tayside's Mental Health Services - That the Parliament welcomes the publication of the final report from the Independent Oversight and Assurance Group on Tayside's Mental Health Services; understands that the report tracks progress against the 51 recommendations made by Dr David Strang in his report, Trust and Respect; recognises that the group has met with staff, third sector and community groups, patients and families while compiling the report; notes the view that progress has been made, including on changes of leadership and clarifying of roles; believes that the report also highlights key areas where recommendations have not seen sufficient action taken, including in the areas of strategic planning, staff appraisals, governance and public performance reporting; thanks the oversight group and all those who contributed to its work, and notes the calls for reassurances that outstanding recommendations will be enacted.

S6M-07511: Foysoyl Choudhury: Damp Housing in Scotland - That the Parliament notes the tragic death of Awaab Ishak due to mouldy housing; notes the view that there is a need for urgent action to avoid similar tragedies happening in Scotland, including in the Lothian region; recognises that mould and damp in homes can be dangerous and cause health problems; understands that the cost of living crisis has caused constituents across Scotland to avoid heating their homes, which can further exacerbate the problem of damp and mould; further understands that damp housing is disproportionately affecting those living in poverty; acknowledges the calls for every constituent in Scotland to have a right to safe, warm housing; notes the view that extra investment for a whole house retrofitting programme is required to tackle problems caused by damp housing; further notes the calls for the creation of a grant scheme to tackle the problems of damp housing across the housing sector, including social housing, housing associations and the private sector; notes the belief that there is a need for increased support and guidance for constituents on the prevention of damp in properties across Scotland; believes that this issue is of nationwide importance, and notes the calls for all political parties in the Parliament to collaborate to tackle damp housing in Scotland.

S6M-07482: Jenni Minto: 100 Years of the BBC in Scotland -

That the Parliament celebrates 100 years of public service broadcasting with the centenary of the BBC in Scotland in 2023; recognises what it sees as the vital contribution of the BBC to the creative economy of the nation; understands that, from the first live radio transmission in Glasgow on the evening of 6 March 1923, the BBC in Scotland has grown from its early days in radio to include the provision of extensive educational resources, Gaelic language content, current affairs, comedy, music and entertainment, reflecting the breadth and depth of Scotland's culture on TV, radio and online; further understands that the BBC in Scotland directly employs over 1,200 people across 14 bases from Shetland to Dumfries, and supports many more roles via commissions to the independent production sector; notes what it considers the value of the BBC and public service broadcasting in Scotland, and the contribution that it has made, and continues to make, to the Scottish creative sector,

and wishes the BBC a successful start to its second century of educating, entertaining and informing the nation.

SS6M-07369: Sharon Dowey: Impact of Long-term Historical Site Closures Managed by Historic Environment Scotland - That the Parliament recognises what it sees as the importance of historic sites to communities across the South Scotland region, and the rest of Scotland; believes that any long-term closures to sites managed by Historic Environment Scotland (HES) could have a severe impact for Scotland's tourism industry, and a devastating impact on any communities and businesses that rely on these attractions being fully open; understands that the heritage sector is a vital part of Scotland's tourism industry, and considers that it is responsible for attracting millions of visitors from around the world to Scotland each year; further understands that 60 historical sites managed by HES are closed, and that the inspection programme is expected to conclude in April 2024; recognises what it sees as the need to address the shortage of skilled labourers, such as stonemasons; notes the calls on the Scottish Government to make additional funding available to accelerate the reopening of closed sites, and further notes the view that it is vital that all efforts are made to secure the long-term viability of Scotland's historic sites.

S6M-07238: Ariane Burgess: Community-led Housing Supporting a Sustainable Future - That the Parliament recognises what it sees as the vital role of community-led housing in tackling the rural and island housing crisis, and in supporting those communities towards a sustainable future; believes that there are diverse and significant challenges facing rural and island communities in providing housing and the varied implications this has for sustaining the rural population; recognises what it considers as the enabling role of community housing trusts and organisations such as South of Scotland Community Housing, Communities Housing Trust and Rural Housing Scotland, which support communities through what it understands can be a burdensome and long process; notes the belief that more can be done to facilitate community-led housing and remove barriers to locally-based projects; further notes the view that there is a need to support community-led affordable housing as a priority, and the potential in the upcoming Land Reform and Community Wealth Building bills to do so; congratulates those organisations that have accomplished community housing projects and utilised available funds such as the Rural and Island Housing Fund; considers that there is a need to learn from these organisations and continually improve, and congratulates what it sees as trailblazing projects that are testing alternative models such as rented cohousing in the Hope CoHousing project in Orkney, and creating place-based communities through models such as Stòras Uibhist and Rural Housing Scotland's Smart Clachan project.

S6M-07215: John Mason: Promoting the Benefits of Camping - That the Parliament welcomes the Outjoyment Report conducted by Liverpool John Moores University and Sheffield Hallam University; acknowledges that the report, commissioned by The Camping and Caravanning Club, surveyed nearly 11,000 people to assess their attitudes toward the benefits of camping; recognises that the report found that 97% of campers said happiness was their top motivator for going

camping, while 48% of campers reported feeling happy almost every day, compared with 35% of non-campers; further recognises that the report found that 93% of people go camping to enjoy being in nature, while 93% of campers value camping for the benefits it has for their health and wellbeing; notes the reported concerns raised by communities around Scotland that short-term lets, such as Airbnb, are changing the make-up of communities and their economies; reflects that, given these considerations, along with what it sees as the need to provide incentives to support local economies following the COVID-19 pandemic, the promotion of camping and its benefits are important; believes that promoting camping is also important in cultivating, especially in children, an appreciation for the environment and a passion to protect it; notes the belief that citizens across Scotland, including in the Glasgow Shettleston constituency, should consider the benefits of camping breaks for both their own health and Scotland's local economy, and thanks Liverpool John Moores University and Sheffield Hallam University for what it considers this insightful report.

S6M-07140: Audrey Nicoll: Increasing the Participation of Women and Girls in Science, Technology, Engineering and Maths - That the Parliament believes that Science, Technology, Engineering and Mathematics (STEM) make an important contribution to driving economic growth and delivering new approaches to the climate emergency; notes the so-called leaky pipeline, whereby women and girls account for only 25% of the STEM sector, despite maths and science subjects being equally popular among girls and boys within school age education; recognises the work underway in schools and further and higher education institutions, including Robert Gordon University, located in the Aberdeen South and North Kincardine constituency, as well as in businesses and energy-related industries, to address the under-representation of women and girls in the STEM sector; welcomes the Scottish Government's STEM strategy and the work of Equate Scotland, which aim to change cultures in organisations and academia; commends Aberdeen City Council and its partners for what it sees as their innovative work to align the school curriculum to future skills demands in offshore energy production and other growth sectors, and notes the view that all stakeholders should continue to work together to increase opportunities for girls and young women in STEM.

S6M-06825: Stephen Kerr: The Children and Young People's Commissioner Annual Report - That the Parliament notes the annual report of the Children and Young People's Commissioner Scotland; thanks the Commissioner and the stakeholders, including those in the Central Scotland Region, who contributed to the work over the course of the last year; notes the findings regarding safeguarding of children and young people, and considers that the role of the commissioner, in ensuring that children are protected from harm and violations of their rights, is of paramount importance to them and to the Parliament.

S6M-06635: Katy Clark: Apprenticeships Budget Freeze - That the Parliament notes with concern reports that the budget for training providers delivering apprenticeship programmes has been frozen; considers that this freeze constitutes a real-terms cut, given the inflation rate has recently risen to as high as 10.1%; notes the Scottish Training Federation's reported comments that this budget freeze means many training providers will have to make redundancies or close their businesses,

without intervention by the Scottish Government; believes that these closures would result in many young people not completing their apprenticeships on schedule, including in the West Scotland region; understands that there is high demand for apprenticeship places; notes the view that creating new work opportunities for young people should be central to Scotland's economic recovery, and further notes the calls on the Scottish Government to come forward with funding to ensure that a further 2,000 apprenticeships are funded in the next six months to meet what it understands is significant employer demand.

S6M-06569: Jamie Halcro Johnston: Road Improvements and the Dualling of the A9 - That the Parliament notes with concern the number of incidents that have taken place on the A9 over recent months and led to road closures, and injuries and fatalities; recognises the Scottish Government's commitments to dual the A9 from Perth to Inverness by 2025, which stand alongside other commitments to road improvements, such as dualling of the A96 by 2030, to support road safety, and provide the economic advantages of connectivity; notes the view that commitments and proposals on investment in the road network have not progressed at pace in recent years and that questions have been raised about the commitment of the Scottish Government to these proposals following the agreement between the Scottish Government and the Scottish Green Party Parliamentary Group; acknowledges the belief that work on the A9, in particular, is clearly not on schedule, and notes the calls for the Scottish Government to reaffirm these commitments on the basis of an updated and achievable timetable that should be presented to the Parliament as soon as possible, in order to reassure communities in the Highlands and Islands and across other regions that committed investment will take place.

S6M-06274: Douglas Lumsden: Channel 4's 40th Anniversary - That the Parliament congratulates Channel 4 on its 40th anniversary; considers that Channel 4 is publicly-owned and commercially-funded, meaning that it can deliver a valuable public service at zero cost to the taxpayer; welcomes what it sees as the important and growing contribution Channel 4 makes to the Scottish production sector, working closely with Screen Scotland; understands that their new Glasgow hub now has the biggest commissioning department by commissioning hours based in Scotland; congratulates Channel 4 for, it understands, surpassing its target to spend half of its original content budget outside of the London area; understands that over 400 roles, encompassing 55% of spend and 66% of hours, are now based outside of the London area; believes that Channel 4 has spent around £220 million on Scottish productions over the last 15 years, with £23.5 million of Scottish spend in 2021; appreciates what it sees as the benefit of Channel 4's skills and training schemes, such as 4Skills, which focuses on social mobility and bringing new, underrepresented voices into the industry; understands that 4Skills will reach 15,000 young people a year from 2022 onwards, including many in Scotland; believes that Channel 4 is a great success story for the UK, and wishes the teams at Channel 4 all the best for many more successful and creative years ahead.

S6M-06140: Jamie Greene: Reinstating the CalMac Season Travel Pass for Isle of Cumbrae Residents - That the Parliament recognises what it considers the importance of the CalMac monthly season pass for travel to Isle of Cumbrae

residents and commuters; further recognises what it sees as the unique challenges that Cumbrae residents face living as part of an island community; regrets reports that CalMac and Transport Scotland have removed the ability to use the pass until further notice; understands that the cost of travel to Cumbrae for residents with the season pass will almost double and place additional pressure on their finances during the global cost of living crisis; notes the calls for the reinstatement of the season travel pass by Transport Scotland as a matter of urgency, and further notes the calls on the Scottish Government, Transport Scotland, CalMac, North Ayrshire Council and locally elected representatives to work together towards the goal of bringing back the season travel pass as soon as is feasibly possible.

S6M-05762: Rhoda Grant: Specialist Neurological Nursing Posts – That the Parliament is concerned by the reported decision of NHS Western Isles to remove the posts of Epilepsy and MS specialist nurse; understands that concerns have been expressed about the long-term future of the Parkinson’s specialist nurse post; notes reports that the NHS board intends to replace these posts with a more generalist advanced neurology nursing post; further notes reports that the NHS board proposes to increase the scope of the nursing post to cover more neurological conditions; considers that this would represent a real terms cut to the service with fewer nursing hours dedicated to supporting more people; notes the view that in a cost of living crisis it is imperative to ensure patients have access to as much care and treatment locally as possible; recognises that there is no on-island neurologists or specialist support and that people with neurological conditions have to travel to NHS Greater Glasgow and Clyde for face-to-face appointments; understands that NHS Greater Glasgow and Clyde does not intend to increase its support to the islands in the wake of this reported cut to specialist nursing provision; recognises what it sees as the importance of the specialist nursing posts in this context and based on the testimony from people living with epilepsy, MS and Parkinson’s on the Islands; understands that this decision was reportedly taken without any consultation with local neurological communities or the national charities that initially helped to fund the posts; further understands that local and national groups have expressed concern that such a cut to specialist nursing provision has the potential to put the safety of those in the local community affected by neurological conditions in jeopardy, and notes the calls from local groups, including Neuro Hebrides, Parkinson’s Western Isles and national stakeholders, including Epilepsy Scotland, MS Society Scotland and Parkinson’s UK Scotland, for NHS Western Isles to work collaboratively with them and people affected by neurological conditions in the Western Isles to deliver a comprehensive service that meets the needs of all stakeholders.

S6M-05506: Craig Hoy: Protecting the Future of Scotland’s Historic Environment – That the Parliament understands that stonemasonry is vitally important for the protection and preservation of Scotland’s historic environment and tourism, and that it can be hugely beneficial to young people from deprived backgrounds to start their career; commends the Ridge Charity in Dunbar, which it understands currently supports some of East Lothian’s most marginalised community members to gain access to modern apprenticeships in stonemasonry and joinery; regrets the reported impending loss of stonemasonry apprenticeships at

Edinburgh College and the impact that this may have on young people in the south of Scotland; notes the calls on the Scottish Government, Skills Development Scotland, Historic Environment Scotland and South of Scotland Enterprise to consider what it sees as the potential serious repercussions for the Ridge Charity and for the apprenticeship opportunities for young people in the south east of Scotland, and further notes the calls for stakeholders, including the Scottish Government, to engage to identify a positive solution for an accessible location that could be used for young people from Berwickshire, Edinburgh and East Lothian to gain access to stonemasonry apprenticeships through a satellite provision of an existing college provider.

S6M-05236: Neil Bibby: Employment in the Low Carbon and Renewable Energy Economy - That the Parliament notes the publication of the bulletin Low carbon and renewable energy economy, UK: 2020 by the Office for National Statistics, which, it understands, found that there had been no significant change in overall levels of employment in the low carbon and renewable energy sectors since the survey began in 2014; understands that estimated full-time equivalent employment in these sectors in Scotland has fallen from 21,500 in 2014 to 20,500 in 2020; notes the view that securing and developing employment, skills and training in low carbon and renewables sectors, including in the West Scotland region, should be a priority for both Scottish and UK governments; further notes the view that at least 50% of employment created by government contracts in the offshore renewables industry should be within the domestic economy in order to support fabrication and manufacturing jobs, and notes calls on the Scottish and UK governments to ensure that the promise of green jobs for the future is realised.
