## MINUTES OF PROCEEDINGS

Parliamentary Year 1, No. 31, Session 6

Meeting of the Parliament

### Thursday 23 September 2021

Note: (DT) signifies a decision taken at Decision Time.

The meeting opened at 11.40 am.

**1. General Questions:** Questions were answered by Cabinet Secretaries and Ministers.

**2.** First Minister's Questions: Questions were answered by the First Minister (Nicola Sturgeon).

3. FASD Awareness Day-9 September: The Parliament debated S6M-01089 in the name of Siobhian Brown—That the Parliament recognises International Fetal Alcohol Spectrum Disorders (FASD) Awareness Day on 9 September, which was first recognised in 1999; notes that the day helps to raise awareness about the range of conditions that can result from alcohol consumption during pregnancy; understands that drinking heavily during pregnancy can risk affecting a child in a number of ways, and may cause learning disabilities, speech and language difficulties, behavioural issues, vision and hearing impairment, and problems with vital organs, among others; commends the excellent work being done by Oshay's FASD organisation, which is based in Ayr, and which offers advice, guidance and support to parents and carers of children who are affected by FASD, and wishes Oshay's FASD group success as it aims to raise awareness of this often undiagnosed condition.

**4. Portfolio Questions:** Questions on Rural Affairs and Islands were answered by a Cabinet Secretary and a Minister.

**5. Ministerial Statement:** The Minister for Transport (Graeme Dey) made a statement and answered questions on Decarbonising Scotland's Transport.

6. Carer's Allowance Supplement (Scotland) Bill: The Minister for Social Security and Local Government (Ben Macpherson) moved S6M-01318—That the Parliament agrees to the general principles of the Carer's Allowance Supplement (Scotland) Bill.

The motion was agreed to (DT).

**7. Carer's Allowance Supplement (Scotland) Bill: Financial Resolution:** The Minister for Social Security and Local Government (Ben Macpherson) moved S6M-01211—That the Parliament, for the purposes of any Act of the Scottish Parliament resulting from the Carer's Allowance Supplement (Scotland) Bill, agrees to any expenditure of a kind referred to in Rule 9.12.3A of the Parliament's Standing Orders arising in consequence of the Act.

The motion was agreed to (DT).

**8. Committee Membership:** The Minister for Parliamentary Business (George Adam), on behalf of the Parliamentary Bureau, moved S6M-01331—That the Parliament agrees —

Sue Webber be appointed to replace Annie Wells as a member of the Health, Social Care and Sport Committee;

Alexander Stewart be appointed to replace Tess White as a member of the Citizen Participation and Public Petitions Committee;

Tess White be appointed to replace Alexander Stewart as a member of the Standards, Procedures and Public Appointments Committee;

Maurice Golden be appointed to replace Sue Webber as a member of the Constitution, Europe, External Affairs and Culture Committee.

The motion was agreed to (DT).
