#### Title of instrument

#### **Purpose**

- 1. Section 140 of the New Roads and Street Works Act 1991 requires that road apparatus must be properly maintained to the satisfaction of the relevant road works authority. The Act allowed for a road works authority to undertake emergency improvements to bring the road apparatus up to standard, following an inspection of the relevant apparatus. However, regulations under that Act stipulated the circumstances in which an inspection was able to be conducted: in such cases where the road works authority has "reasonable cause to believe, by reason of subsidence or disturbance of the road surface, that the undertaker's apparatus has not been maintained".
- 2. The Regulations that are under consideration by the Committee seek to extend the circumstances in which emergency improvements can take place by specifying that such works may follow any inspection rather than just those reasons for an inspection set out in paragraph 1 above.

#### Consideration by the Subordinate Legislation Committee

3. On 6 November, the Subordinate Legislation Committee considered the Regulations and determined that it did not need to draw the attention of the Parliament to them.
