## PETITION PE1534 - EQUAL RIGHTS OF APPEAL IN THE PLANNING SYSTEM

On 27 January 2015 the Public Petitions Committee referred Petition PE1534, lodged by Clare Symonds on behalf of Planning Democracy, to the Local Government and Regeneration Committee. The petition calls on the Scottish Parliament—

"to urge the Scottish Government to review the current rights of appeal within planning and other consenting processes which give deemed planning consent, considering the benefits of widening the scope of appeal, and providing an equal right of appeal."

The Committee considered its approach to this petition at its meeting on 1 April 2015. The Committee agreed to write to you seeking the views of the Scottish Government on the current rights of appeal within planning and other consenting processes. The Committee also wishes to know if the Government has any plans to review these processes.
