## Public Petition PE01547 on conserving Scottish Wild Salmon

At its meeting on 9 March 2016<sup>1</sup> the Rural Affairs, Climate Change and Environment Committee considered your petition PE01547 on conserving Scottish Wild Salmon. Earlier in the meeting the Committee considered and rejected a motion to annul the Conservation of Salmon (Scotland) Order (SSI/2016/115).<sup>2</sup> As a result, the regulations contained in this Order relating to the conservation of salmon stocks in Scotland will come into force on 31 March 2016.

During the Committee's debate on the motion to annul the Order, the Cabinet Secretary for Rural Affairs, Environment and Food, Richard Lochhead MSP (the Cabinet Secretary), confirmed the intention of the Scottish Government to move to a salmon conservation strategy, as soon as is possible, based on the best scientific evidence available and centred on a river-by-river approach.<sup>3</sup>

The Cabinet Secretary undertook to report back within 12 months to our successor committee in the next Session of the Parliament, on the progress of the Government's wild fisheries reform programme. This report will also cover the development of a data and research strategy to identify gaps in the scientific base underpinning decisions on wild fisheries management.<sup>4</sup>

As you will no doubt be aware, the strategies referred to by the Cabinet Secretary are part of the Scottish Government's draft provisions for a Wild Fisheries (Scotland) Bill and draft Wild Fisheries Strategy.<sup>5</sup> The Government is currently undertaking a public consultation on the draft strategy and draft bill, and this will close on 2 May 2016.<sup>6</sup>

We expect the outcomes from this consultation to come before our successor committee in the next Session of the Parliament as part of that committee's scrutiny of a Wild Fisheries Bill. The Committee has agreed to draw these issues to the attention of our successor committee by way of our Session 4 Legacy Report, which was published on Monday 14 March 2016.<sup>7</sup>

In light of these positive developments, the Committee agreed to close your petition. On behalf of the Committee, can I take this opportunity to thank you for lodging your petition and for participating in the scrutiny of the formulation of Scottish Government policy in this important area.

I am copying this letter to the Cabinet Secretary for Rural Affairs, Food and Environment, the Minister for the Environment, Climate Change and Land Reform and officials at Marine Scotland, for their information.

I am also copying this to the Clerk of the Public Petitions Committee in relation to the closing of your petition.
