Standards, Procedures and Public Appointments Committee 10th Meeting 2015 (Session 4), Thursday 4 June 2015 Cross-Party Groups – six monthly monitoring report

Introduction

- 1. The Standards, Procedures and Public Appointments (SPPA) Committee is responsible for overseeing the Cross-Party Group (CPG) system. As part of this role it considers regular monitoring reports on the work undertaken by groups and their compliance with the rules in the Code of Conduct for MSPs (Section 6, volumes 2 and 3).
- 2. As is apparent later in the report, the steps taken by the Committee following its review of the CPG rules in 2012 continue to generate a positive response from groups. There has been a noticeable increase in the level of information readily being provided to the Standards clerks since the start of the session, with each of the successive monitoring reports showing greater compliance than the last.

Examples of work undertaken by groups

- 3. Annual returns submitted detail specific pieces of work that allow for information sharing and collaboration within the policy community. As noted in the Committee's review <u>report</u>, amongst other things, this work provides MSPs with information that aids them in scrutinising the Scottish Government. Some extracts of minutes detailing the work undertaken by groups, are detailed below.
- 4. This is just a sample selection. Full details of the work undertaken by groups are available in the annual returns which have been circulated to members and are all on the Cross-Party Group <u>website</u>.
 - Armed Forces Veterans meeting on 30 September 2014

The newly appointed Scottish Veterans Commissioner attended the meeting to give the Group an overview of his background and experience. Keith Brown MSP, the then Minister for Transport and Veterans spoke to the Group on the appointment of the Commissioner.

Diabetes meeting on 25 November 2014

Dr Julia Platts, a lead clinician on Diabetes in Wales, presented to the Group on the experience of the Diabetes Delivery Plan in Wales. This gave opportunities for shared practice.

Housing meeting on 6 November 2014

Michael Cameron, Chief Executive of Scottish Housing Regulator attended the meeting to discuss the Thematic Inquiry into Housing Options and Homelessness Prevention.

Men's Violence Against Women and Children event on 4 December 2014

Event held in the Scottish Parliament during 16 Days of Action. Statement of Intent signing event to recognise the achievements in Scotland in tackling violence against women, and to engage the Scottish Parliament in committing the necessary support to meet the outcomes detailed in the recently published national strategy, 'Equally Safe'. 43 MSPs attended and signed the Statement.

Tobacco and Health meeting on 9 October 2014

The meeting was attended by representatives from The Youth Commission on Smoking Prevention, which had been tasked by The Scottish Government to make recommendations on future youth prevention smoking activity in Scotland. Jordan Linden from the Commission summarised the purpose and remit of The Commission.

Towns and Town Centres meeting on 1 October 2014

Derek Mackay, Minister for Local Planning and Government attended the meeting and provided the group with an update of activity being carried out under the Town Centre Action Plan and announced that STP would be awarded a £186,000 grant to act as the 'go-to' body for towns in Scotland.

Volunteering and the Voluntary Sector meeting on 18 June 2014

The topic for June's meeting was Glasgow 2014 Volunteering Journey & Volunteering Legacy. The group was joined by Neil Campion, General Manager, Volunteer Recruitment Glasgow 2014 who gave a presentation to members about how volunteers were recruited and trained for Glasgow 2014; what those volunteers looked like (i.e. demographic, geographic breakdown) and what the response had been from the public and media to Glasgow 2014 Volunteers. The group then heard from George Thomson CEO of Volunteer Scotland about the volunteering legacy of the games and the use of the My Volunteer Account system.

Compliance

5. The requirements placed on groups under the Code are listed below, followed by details of compliance from groups over the past 6 months.

Membership

- 6. Groups must have—
 - at least 5 MSP members
 - at least one MSP from each of the parties or groups represented on the Parliamentary Bureau (in practice the Committee has waived this requirement in this session, requiring the SNP, Labour Party and Conservatives to be represented); and
 - at least 2 MSP office bearers.
- 7. All groups are currently meeting these requirements.

Operation of Group

- 8. Groups must—
 - hold at least two meetings per year, and one of these must be the AGM.
 - announce meetings in advance via the Parliament website with meeting details notified to the Standards clerks at least 10 calendar days in advance of the meeting.
 - hold an AGM once every 12 months following the date of the Group's establishment and submit annual returns within 30 days of the AGM being held – for publication on the Parliament website.
 - provide minutes of meetings, including attendee lists to confirm meetings are quorate, for publication on the Parliament's website.
- 9. All groups are currently meeting these requirements.

Meetings

- 10. Of the 88 Groups, 81 of them have either met twice in the period after their second last AGM (these two meetings can include their most recent AGM), or will have met twice by their next AGM.
- 11. The CPG on Golf has not met twice and the reason for this, given by the Convener of the Group, was that the development of plans to amalgamate the Scottish Golf Union (SGU) and Scottish Ladies' Golfing Association (SLGA) into a single unified governing body, coupled with what was such a busy year for golf in Scotland, has meant that the SGU who act as the secretariat for the group have been unable to facilitate a suitable time.
- 12. The other six Groups are—
 - Funerals and Bereavement the AGM is not due until 12 November 2015 so there is time for the Group to hold another meeting.
 - Japan the AGM is not due until 5 November 2015.
 - Life Sciences the AGM is due on 17 June 2015, clerks have emailed the Convener of the Group on three occasions, 2 February, 25 March and 29 April 2015 to remind him of the requirements in the Code.
 - Park Homes the AGM is not due until 5 August 2015. Given the Summer Recess the Convener has been emailed to highlight the requirements of the Code.
 - Russia the AGM is not due until 16 December 2015.
 - Video Games Technology the AGM is due on 12 June 2015, clerks have emailed the Co-Conveners of the Group on three occasions, 2 February, 17 March and 29 April 2015 to remind them of the requirements in the Code. Groups are required to give 10 days' notice of any meeting and so clerks will update the Committee at the meeting on 4 June as to whether an additional meeting has been organised and, if not, whether any reason has been offered.
- 13. The following Groups met but did not give the required 10 calendar days' notice—

14. These Groups have been reminded of the requirement in the Code to notify the Standards Clerks 10 days prior to any meeting.

AGMs

- 15. Since the report in November 2014 49 Groups should have held AGMs. Out of the 49 Groups there are two Groups that have not held their AGMs—
 - Learning Disability (was due to be held on 28 May 2015) this Group wished to meet during Learning Disability Awareness Week and have booked their AGM for 16 June. They found it difficult to get the Group together to meet before that date; and
 - Sport (was due to be held on 27 May 2015) the AGM for this CPG has tended to be held in either June or September/October. Margo MacDonald was the Convener. The Group delayed the AGM to provide additional time to Group members in relation to the AGM, including those who may wish to consider standing for election to one of the Group positions. The intention is to hold an AGM in September/October
- 16. Out of the 47 Groups that have held AGMs, the following 14 Groups held them late; where delays are short (under 10 days), the number of days is highlighted in the table below. The reasons provided by the Groups for longer delays are also detailed—

22. Having considered the information on compliance, the Committee is invited to consider whether it wishes to take any action in relation to non-compliant groups.
