I am today making appointments to an Expert Advisory Group on Migration and Population, and I wanted to provide the Committee with more information on the membership and role of this group.

I believe it is essential for the discussion and debate on future migration policy, in the context of the UK leaving the EU and with a White Paper and draft Immigration Bill on the horizon, that we have the benefit of a rigorous and shared understanding of what the evidence tells us about policy options. The Migration Advisory Committee (MAC) has just completed its largest ever piece of work, responding to a commission from the Home Secretary on the impacts of migration on the UK labour market. While I disagree with many of the policy recommendations the MAC has made, I do recognise that they have amassed an impressive body of analysis and evidence which clearly sets out the benefit of migration to the UK economy.

For clarity, I have not established this Expert Advisory Group on Migration and Population in opposition to or as a rival to the MAC. Instead, this Expert Advisory Group on Migration and Population will be an independent source of advice and expertise on what the implications are of the evidence and policy choices on migration for areas of devolved responsibility in Scotland. I am very pleased that Professor Christina Boswell of the University of Edinburgh has agreed to Chair this group. Professor Boswell is Chair of the Royal Society of Edinburgh Working Group on Immigration and Diversity, and I am sure will be known to members of the Committee through her recent work on options for immigration policy after Brexit.

Professor Boswell will be joined by a range of experts from relevant disciplines, including Professor David Bell of the University of Stirling, Dr Andrew Copus of the James Hutton Institute, Professor Rebecca Kay of the University of Glasgow, and Professor Hill Kulu of the University of St Andrews. I enclose at Annex A with this letter short biographies of the Chair and Members.

The remit of the group is as set out in Annex B, and I also enclose a copy of my letter to the Chair setting out the first commission I have instructed the group to investigate. The group will have secretariat and administrative support from my officials in the Scottish Government, but its findings and any recommendations it makes will be independent.

I have asked the group to report on the initial commission early next year. In the meantime, I am of course very happy to provide further information that members of the Committee would find helpful.

### TERMS OF REFERENCE

#### Remit

The Expert Advisory Group on Migration and Population ("the group") will give independent expert advice to the Scottish Government on migration, population growth and demographic change.

The group's responsibilities are to:

- Respond to written commissions from the Scottish Ministers;
- In doing so, consider the effects of migration, population growth and demographic change on (a) Scotland's economy, (b) Scotland's communities, (c) the operation of devolved public services in Scotland, and (d) any other area of devolved responsibility specified by the Scottish Ministers in a commission to the group.
- As appropriate, review evidence, undertake research and prepare analysis to inform the group's response to commissions from the Scottish Ministers.

#### Resources

The group will have access to administrative and secretariat support from officials in the Scottish Government. The group will also be able to request analytical input from relevant professional groupings in the Scottish Government as necessary.

I am grateful to you and the Members of the Expert Advisory Group on Migration and Population for agreeing to provide your independent expert advice to the Scottish Government on these crucial long-term questions for public policy. I am writing now to provide you with the first commission to the group from the Scottish Government.

While powers over immigration are reserved, issues of migration, population growth and demographic change have a clear impact on devolved responsibilities of the Scottish Parliament and the Scottish Government. These include growth of the Scottish economy, the sustainability and wellbeing of communities, and the operation of devolved public services.

Within the terms of the remit attached to your appointment letter, the group should review the policy recommendations made by the Migration Advisory Committee in their response to the UK Government in their main report on labour market impacts, in order to identify the potential effects of those recommendations on immigration to Scotland. The group should consider and advise on how such changes to immigration might potentially impact areas of devolved competence in Scotland.

In line with the terms of reference for the group, you are able to draw on administrative and secretariat support from my officials in the Scottish Government. You are also able to request analytical support as necessary from the relevant economist, statistician and social research teams in the Civil Service. However, the findings of the group will be yours alone, and independent of government.

It is up to you as Chair to determine how the group approaches this commission and draws on the available resources to support it in its work. You should prepare a workplan for agreement with my officials in the course of your first meeting, setting out how the group proposes to respond to this commission.

I look forward to your full response, which I would be grateful to receive before the Scottish Parliament recess in February 2019.
