Local policing

Note by the Clerk

Introduction

1. At its meeting on 3 October 2013, the Sub-Committee agreed to hold an evidence session on local policing, including the current review of public counter service provision.

Committee interest in local policing

Previous consideration

- 2. One of the main policy objectives behind police reform was to strengthen the connection between services and communities by creating a new formal relationship with each of the 32 local authorities and integrating with community planning partnerships¹.
- 3. The Sub-Committee identified local policing as an early area of interest at its first meeting and agreed to hold an initial evidence session on the transition to the new local arrangements on 18 April 2013 with DCC Rose Fitzpatrick, who has responsibility for local policing.
- 4. During evidence, the Sub-Committee examined how scrutiny of local policing and the approval of local police plans were being carried out across local authorities in the early weeks of reform. - 5. Following this session, the Sub-Committee received supplementary written evidence on how local commanders engage with local democratic structures. This has been reproduced as Annexe A to this note.
- 6. The Sub-Committee agreed to return to the issue of local policing later in the year once the new arrangements had time to bed in.

Recent developments

Public counter services review

7. In June 2013, Police Scotland wrote to the Sub-Committee outlining plans to review traffic warden provision and public counter services. The letter stated that—

"The Chief Constable has [also] commissioned a review of the level of public service that occurs at police stations and to determine the most efficient opening times to the public and the services provided."

Her Majesty's Inspector of Constabulary for Scotland thematic report

- 11. In May 2013, Her Majesty's Inspector of Constabulary for Scotland (HMICS) published a thematic inspection of the development of local police plans and arrangements for local scrutiny and engagement. This review provided an early overview of emerging arrangements in relation to local policing issues and its main recommendation was that a more comprehensive review will be required in early 2014 in order to properly assess how local scrutiny and engagement structures are working in practice.

DIVISION	ARRANGEMENTS FOR ENGAGEMENT
Aberdeen City	The Divisional Commander personally attends the meetings of the Local Scrutiny Committee which take place every 6 weeks.
	Furthermore, the Divisional Commander is also Vice Chair of Community Planning Aberdeen which also provides a reporting mechanism. A divisional Superintendent also attends each meeting of Aberdeen City Community Safety Partnership.
Aberdeenshire &	The Divisional Commander personally attends the meetings
Moray	of the Local Scrutiny Committee and is accompanied on each occasion by the Superintendent (Operations), Superintendent (Support) and Chief Inspector (Local Accountability)
	The Divisional Commander submits a report in advance providing information on performance, operational updates, resources and establishment.
Tayside	The Divisional Commander personally attends the meetings of the Local Scrutiny Committee in each Local Authority area within the division. The Commander is supported at the meetings by the respective Chief Inspector (Support) and Area Commander.
Highland & Islands	The Divisional Commander personally attends the meetings of the Local Scrutiny Committee in each Local Authority area within the division.
	If attendance by the Divisional Commander is not possible due to date clashes between the four authorities or logistical

	difficulties owing to restricted transport between outlying areas, the Commander will be represented by a Superintendent or Area Commander.
Forth Valley	The Divisional Commander personally attends the meetings of the Local Scrutiny Committee in each Local Authority area within the division and will be accompanied by the respective Area Commander.
	Both officers also attend the agenda setting meetings to ensure complete preparedness to provide the required information at the full meeting.
Edinburgh City	The Divisional Commander personally attends the meetings of the Local Scrutiny Committee and will ask selected members of staff to also attend dependent on the key business on the agenda.
	The Divisional Commander also attends the agenda setting meeting and meets regularly outwith the meeting cycle with the Convenor/Chair to provide interim updates as required.
Lothian and the Scottish Borders	The Divisional Commander personally attends the meetings of the Local Scrutiny Committee in each Local Authority area accompanied by the respective Area Commander.
Greater Glasgow	The Divisional Commander personally attends the meetings of the Local Scrutiny Committees.
	In East Dunbartonshire and East Renfrewshire, the Divisional Commander is accompanied by the respective Area Commander.
Fife	The Divisional Commander personally attends the meetings of the Local Scrutiny Committee which take place every 6 weeks.
	The Divisional Commander also attends the agenda setting meeting with the Convenor where specific reports are requested.
	A presentation is provided by the Police at each meeting on a topical policing matter.
Ayrshire	The Divisional Commander personally attends the meetings of the Local Scrutiny Committee in each Local Authority area accompanied by the respective Area Commander.
	The Divisional Commander also brings each of the local Superintendents, on a rotating basis, to both the Scrutiny and full Council meetings to ensure awareness of local need, demand and expectation.

	Written performance updates are also provided to the Scrutiny committees outwith the formal meeting cycle.
Lanarkshire	The Divisional Commander personally attends the meetings of the Local Scrutiny Committee in each Local Authority area which are each held on a quarterly basis.
	Furthermore, the Divisional Commander also holds a surgery for elected members in both authority areas on a weekly basis to discuss local policing matters and has meetings scheduled quarterly with the Local Authority Chief Executives to specifically discuss the Local Policing Plan.
Argyll & West Dunbartonshire	The Divisional Commander personally attends the meetings of the Local Scrutiny Committee in each Local Authority area.
	The Divisional Commander will be represented at the meetings by a Superintendent by exception only.
Renfrewshire & Inverclyde	The Divisional Commander personally attends the meetings of the Local Scrutiny Committee in each Local Authority area.
Dumfries & Galloway	The Divisional Commander personally attends the meetings of the Local Scrutiny Committee.
	The Divisional Commander will also attend full Council meetings when there are issues being discussed which will impact on policing. The relevant Area Commander will attend Multi Member Ward Committee meetings.
